
Construction of Noise Attenuation Wall Eglinton Avenue West (South Side) at Hewick's Lane

Construction Work: on or after May 10 - August 15

Scope of Work

The City of Mississauga will be constructing a new concrete noise attenuation wall along the side of your property. Construction includes pruning of trees, removal of the existing fence, installation of temporary fence and the installation of the new concrete noise wall with all restoration work. There is no direct costs to you, for the removal and replacement of the noise attenuation barrier. All work including the removal of the existing fence/retaining wall will be removed by the City contractor.

We ask that you please remove any attachment such as vegetation, sheds, planters, or irrigation heads that are connected to the existing fence/retaining wall or within one (1) metre of the existing fence. If they are damaged, they will not be reinstalled or repaired by the City. The City of Mississauga accepts no responsibility for any damages to private fixtures placed on the existing wall or on City property.



COVID-19 Update: Taking Steps to Stop the Spread

The construction project that will be taking place is an essential service under the recently enacted Ontario Regulation 82/20 because it involves the repair and maintenance of the City's infrastructure. The City's Contractor is required to carry out all construction activities in accordance with all applicable laws, including the *Occupational Health and Safety Act* (and regulations) and the advice, recommendations and instructions of public health officials. These recommendations include training of all employees, contractors and trades on COVID-19 policies, maintaining physical distancing of 2 metres, providing on-site sanitation, and tracking and monitoring of workers and site visitors. The City will closely monitor and work with the Contractor to ensure complete adherence to all COVID-19 regulations and policies. The Province has also advised that they will be increasing the number of Ministry of Labour Inspectors to ensure that essential businesses are complying with the health and safety requirements.

What to Expect During Construction

Impacts	There will be some construction related dust, noise and traffic delays. The City will make every effort to reduce the impacts. We appreciate your patience and cooperation.		
Work Hours	Work will occur between 7:00 a.m. to 7:00 p.m., Monday to Friday.		
Traffic and Pedestrians	Roads	One vehicle lane on south side of Eglinton Avenue West will be closed temporarily daily to traffic, from Hewick's Lane to Culham Trail. Please follow traffic signage posted on-site.	
	Sidewalks / Multi-Use Trail	Sidewalk on south side of Eglinton Avenue West, from Hewick's Lane to Culham Trail will be closed temporarily daily during construction. Please follow detour signage posted on-site.	
Transit Service	MiWay Transit stop #3504 will be out of service temporarily during construction.		
Parking	On-street parking will not be available at this time.		
Restoration Works	The construction site will be restored with sod after construction has been completed.		
Utility Disruptions	Temporary disruptions to utilities (i.e. gas, hydro, water, telecommunications and cable TV) may be experienced. Every effort will be made to promptly restore service.		

Future updates will be provided should there be changes to the project.
